A lightweight, comfortable and protective flame-resistant piqué Long-sleeve T-shirt designed for demanding industrial environments.

Constructed from, a 230 g/m² knitted fabric composed of 60% modacrylic, 38% cotton and 2% carbon antistatic fibre, the T-shirt combines inherent flame resistance, antistatic performance, thermal comfort and natural cotton comfort.
